TENDER NOTICE


As approved by the Chairman District Health Society (District Development Commissioner Udhampur sealed tenders are invited from permanent resident of J&K State for empanelment of Light Motor Vehicle Operators in District Udhampur for the Mobile teams under Rashtriya Bal Swasthya Karyaram in district Udhampur.

The interested parties/Travel Agencies are requested to submit the sealed tenders affixed with Rs.5.00 revenue stamp (clearly marked on the envelop- bid for hiring of vehicle) for the Mobile teams under RBSK in District Udhampur. The sealed tenders must reach in the office of Vice chairman District, Health Society Udhampur (Chief Medical Officer Udhampur) on or before 12<sup>th</sup> March 2016 up to 1 PM and will be opened on same day (12<sup>th</sup> March 2016) at 2 PM in the office of the District Development Commissioner Udhampur. The tenderers may also participate in tender opening meeting personally or their authorized representative. The acceptance and finalization of tenders will be subject to the following terms and conditions.

TERMS AND CONDITIONS:

1. The minimum numbers of vehicles required is 12 (twelve).
2. The commercial vehicle required should be of make Tata Sumo, Bolero, Scorpio, Tavera, Omni Van (non A/C) and in motorable condition not prior to 2010 model with complete documents required under rule. The drivers of vehicle also possess the requisite documents and in proper uniform. The tenderer is bound to provide all the twelve vehicles on minimum approved rates quoted by him in his tender.
3. These rates shall be operative up to 31-03-2017.
4. The Travel Agencies may quote the rates of hiring on monthly basis including repairs, fuel and driver etc.
5. The successful tenderers shall execute an agreement with the District Health society Udhampur under the prevailing norms. In case, the successful tenderer breaches the agreement he shall be liable for forfeiting of security.
6. The District Health Society is empowered to disengage any vehicle any time if the vehicle becomes defective or on the basis of any other unavoidable circumstances. The tenderer will have to get repair the vehicle or replace within 24 hours if any vehicle becomes defective.
7. The tenderers should accompany CDR of Rs.65000/- (Rupees Sixty Five Thousand only) pledged to Chief Medical Officer Udhampur as security which shall be released to successful tenderers after completion of Contract. The security will be refunded to unsuccessful tenderers after the tender process is completed.

8. The tenderer should be registered with govt. department having TIN & PAN so that Service Tax, income Tax, Labour cess is deducted and credited to the proper accounts. Further payment of passenger Tax shall be the liability of the Travel Agency.
9. The committee reserves the right to accept or reject any tender without assigning any reason there for.
10. The tenderer must attach the photocopies of the TIN, PAN Number, and registration certificate issued by the concerned Govt. department.
11. The successful tenderers/parties are bound to ensure that the vehicle provided under the scheme is immediately branded by the concerned parties on their own cost as per the specification provided to them by department within week, time. In case of failure no payment will be made.
12. The driver of the vehicle will station their vehicle at Block Headquarter after working hours and during night hours. They will not indulge in utilizing vehicle for private purpose during the period of contract.
