**The sanction accorded is subject to following conditions:**

1. That while hiring of these specialists Mission Director, NRHM or his representative from State Health Society will be part of the selection committee.
2. That the above sanctioned GIA is incurred strictly as per instructions conveyed to you vide this office No.NRHM/SHS/J&K/2720-22 dated 8.6.2011.
3. That the Specialists hired are placed in position at FRUs only. In rare case of any dire need for placing any Specialists other than FRUs, prior permission from the State Health Society be obtained in such case with specific reasons and remarks.
4. That the work done report of each of the Specialist is sent to the State Health Society on monthly basis.
5. That the funds are utilized after observing all codal formalities required under rules.
6. That the Statement of Expenditure and Utilization Certificate is sent to the SHS regularly on quarterly basis.
7. The account of the grantee shall be open to the inspection by the sanctioning authority and Audit both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and internal Audit by Principal Accounts Office of the Ministry of the Health & Family Welfare, GoI, whenever the grantee is called upon to do so.
