- That the District Health Socities/Institutions shall ensure the display of JSSK slogans and other benefits under NRHM on hoardings at prominent places of their respective insitution
- That the proper record of cash books, ledgers, Assets created complete address of beneficiaries and other relevant records are maintained at all levels.
