You are, therefore, requested to release the above sanctioned funds in favour of above mentioned trainees for disbursement of their TA/DA claim.

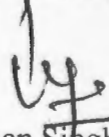
The Grant-in-Aid released is subject to following conditions:

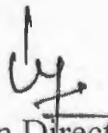

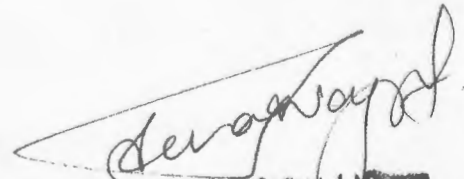
