The Grant-in-Aid is subject to the following conditions:



2. ***That the benefit of 5% increment on the existing rates of salary shall be given w.e.f. 1st April, 2015 to those officials whose contracts have been executed or renewed between 1st April, 2014 to October, 2014.***
3. That the funds are to be utilized strictly after observing all formalities required under rules and guidelines of MoH&FW, GoI.
4. That the statement of Expenditure and Utilization Certificate are sent to the State Health Society regularly.
5. That the proper record of Bank Column Cash Books, Ledgers, Assets Register and other relevant records is maintained for check of any visiting team from Central/State Government.
