Sir,

In reference to DPR submitted by the your office vide letter No.DHSK/Plg/NHM/17-18/1788-89 dated 6/12/2017 and as per the decision taken in the meeting of Executive Committee, SHS, J&K held on 11th October, 2017, sanction is hereby accorded to release of Grant-in-Aid of **Rs.14.56 Lacs (Rupees Fourteen Lacs and Fifty Six Thousands only)** under Mission Flexible Pool for setting up of Dialysis unit at District Hospital, Anantnag.

Accordingly, the above sanctioned funds is hereby electronically transferred into your official **Bank Account No. SB-29893** of J&K Bank Ltd, GMC, Srinagar.

The Grant-in-Aid is sanctioned subject to the following conditions:

1. That the above sanctioned funds are exclusively meant for fabrication aluminum partition in the District Hospital, Anantnag for installation of Dialysis Machines under NHM strictly as per requirement and specifications of M/s Fair Fax India.
2. That the Directorate should be registered as agency on PFMS portal to enable this office for release of funds under NHM in future as per the conditionalities of MoH&FW, GoI
3. That no diversion of funds is permissible without approval of the Competent Authority.
4. That the sanctioned funds are to be utilized strictly as per the approvals issued by the MoH&FW, GoI and after observing all the codal formalities required under financial rules.
5. That the Physical/Financial achievements along with Statement of Expenditure & Utilization Certificates are to be sent to the State Health Society.
6. That all the structure/buildings supported under NHM should prominently display the Logo of NHM in English, Hindi and regional languages.
7. That the proper record of Bank Column Cash Book, Ledger, Assets and other relevant records should be maintained at all levels for the inspection of any visiting team Central/State Govt. team.
8. The accounts of the grantee shall be open to inspection by the sanctioning authority and audit by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and internal audit by Principal Accounts Office of the Ministry of Health & Family Welfare, Government of India, whenever the society is called upon to do so.
